# Introduction

The Alberta Student Aid Scholarships and Awards Operational Policy Manual is intended to provide scholarship specific policy and procedure guidance to Alberta Student Aid staff, stakeholders, post-secondary institutions, and students.

Unless otherwise indicated, the policies and procedures described in this manual are effective for study periods starting on or after August 1, 2024 until July 31, 2025, which is considered the Alberta Student Aid funding year.

The manual provides policy guidance for Advanced Education's scholarships and awards. The scholarships and awards listed throughout this manual are paid directly through Advanced Education's budget. Unique scholarship and award criteria will be specified in the subsections of this manual.

The manual follows the same formatting throughout. References to the <u>Student Financial Assistance Act</u>, S.A. 2002, c. S-20.5 or the <u>Student Financial Assistance Regulation</u>, A.R. 298/2002, and the <u>Alberta Heritage Scholarship Act</u>, R.S.A. 2000, c. A-24 or the <u>Alberta Heritage Scholarship Regulation</u>, A.R. 214/1999 provide authority for the policy and are listed at the beginning of each section and noted with the following icon:

Alberta Student Aid policy is shown in bolded text and all other procedures, clarifying notes and examples are written in regular text. In some cases, the legislation has been summarized for convenience. In the case of a conflict between the legislation and this document, the legislation prevails. This manual only applies to Alberta Student Aid policies and procedures. However, in some cases explanation on how Alberta Student Aid administers the Canada Student Loan Financial Assistance Program is included for clarity.

# **Scholarships**

Scholarships are provided to students based on specific eligibility criteria to encourage access and participation in post-secondary education, and to reward academic excellence.

#### **Awards**

Awards are provided to students based on specific eligibility criteria to encourage access and participation in post-secondary education, and incite participation in activities such as community involvement, leadership, or athletics.

#### **Bursaries**

Bursaries are provided to students based on financial need or the need to remove financial obstacles to access post-secondary education.

# **Delivery**

All Alberta Advanced Education scholarships, awards or bursaries are delivered through the use of Advanced Education's budget; the budget allocated is at the sole discretion of Advanced Education.

The following scholarships and awards are subject to the Alberta Student Aid policies and procedures noted in this chapter to determine a student's eligibility.

All scholarships and awards offered through Advanced Education directly will not include grant agreements. Advanced Education's policies noted in this chapter are administered and paid directly through Advanced Education's budget.

Any and all exceptions to this delivery method will be specified in subsections of this chapter. Scholarships and Awards programs are not included in Alberta Student Aid's Request for Review (RFR) process.

# **Eligibility Criteria**

Eligibility for a scholarship or award is determined specific to each scholarship and award.

# **Citizenship and Immigration Status**

SFA Reg.: Schedule 2, ss. 1(2) and 1(3)
AHS Reg s. 1(g)

Unless otherwise indicated for unique scholarships and awards, the general eligibility criteria for scholarships or awards delivered through Alberta Student Aid, a student must either be a:

- Canadian citizen, or
- permanent resident of Canada, or
- protected person, as defined in the <u>Immigration and Refugee Protection Act</u> (Canada).

A student must have a valid Canadian Social Insurance Number (SIN) to be eligible for financial assistance from Alberta Student Aid. Students with questions about applying for a SIN may contact:

Protected persons must be able to document that their protected person status is valid at the start of their current study period.

Protected persons must provide copies of the following documentation:

- a temporary Social Insurance Number (SIN) card or confirmation of SIN letter showing a 900 series SIN number, and
- a Notice of Decision issued by the Immigration and Refugee Board or Verification of Status document issued by Immigration, Refugees and Citizenship Canada. Protected Persons Status Documents issued prior to January 2013 are acceptable as well.

Unless otherwise indicated, students with only a study permit or a work permit are not eligible for scholarships or awards from Alberta Student Aid.

Students must also meet Alberta residency criteria and other eligibility requirements to be eligible for scholarships and awards.

# Residency

To be considered for scholarships and awards, a student must be a resident of Alberta.

Unless otherwise indicated, a student is considered to be a resident of Alberta, if they meet one of the following conditions:

- one parent or legal guardian has maintained permanent residence in Canada for at least twelve (12) consecutive months immediately prior to commencing postsecondary studies and be residing in Alberta, or
- Alberta is the last place the student has lived for twelve (12) consecutive months immediately prior to commencing post-secondary studies, or
- the student's spouse/partner has maintained permanent residence in Alberta for 12 consecutive months prior to the person attending post-secondary studies.

The time spent as a full-time post-secondary student in Alberta does not count towards the length of time required to establish residency in Alberta.

#### **Full-Time Status**



Generally speaking, for scholarships and awards delivered by Advanced Education, to be considered full-time by Alberta Student Aid, a student must be registered in at least 60% of a full course load in a designated post-secondary program.

To be eligible for the scholarship or award, a student must be full-time at the time of application, and at the time the scholarship or award is paid to the student.

For full-time enrolment:

- Post-secondary institutions determine what constitutes a full course load in each of their programs.
- No averaging of course loads between semesters is permitted (e.g., a student cannot take 80% one semester and 40% in the following semester).
- Courses counting towards the 60% must be post-secondary courses and must be taken for credit.

#### **Concurrent Enrolment**

A student is considered concurrently enrolled when the student:

- attends more than one designated post-secondary institution at the same time;
   and
- is not considered a full-time student at any one of the institutions; and
- is considered a full-time student when the courses at each institution are added together, as determined by the post-secondary institutions.

A primary institution will need to be identified and listed. The student should contact their post-secondary institutions to determine which institution should be the 'primary institution' and notify Alberta Student Aid if they are concurrently enrolled when they apply for the scholarship/award.

The primary institution is responsible for confirming the student's registration. The postsecondary institutions should work with each other to determine whether the student considered a full-time student for scholarship/award programs.

Enrolment status must be verified before the scholarship/award can be paid.

# **Program Eligibility**

# **Designation of Institutions and Programs**

As the purpose of each scholarship and award program differs, the applicable institutions and programs offered will also vary. For more details, see the application form for each scholarship or award.

Students will be able to access scholarships and awards designated via grant agreements to post-secondary institutions, which have existing public funding agreements or nominations from post-secondary institutions including, but not limited to the following:

- Comprehensive academic and research universities
- Comprehensive community colleges
- Independent academic institutions
- Polytechnic institutions
- Specialized arts and cultural institutions
- Undergraduate universities

#### • First Nations Colleges

Effective August 1, 2023, no new additional post-secondary institutions (independent academic institutions, specialized arts and cultural institutions, First Nations Colleges are eligible to receive grant agreement funding for the purposes of scholarships, awards and/or bursaries. For profit institutions are not eligible for Alberta Student Aid Scholarship and Award grant funding.

# **Application Availability**

SFA Reg.: Schedule 2, ss. 1(1)(k) and 11(1.1)
AHS Reg (1)

Alberta Student Aid's scholarship and award applications are available August 1. The Alberta Student Aid scholarships and awards funding year is based on a student's study period start date. If a student's study period begins:

- on or after August 1, 2024, they must complete the applicable application forms dated 2024-2025 for the scholarship/award.
- on or after August 1, 2025, they must wait for the release of the 2025-2026 scholarship/award applications available August 1, 2025.

Applications for the scholarship and awards programs can be found on the <u>Alberta Scholarships</u> page on studentaid.alberta.ca. Students must submit completed applications to Alberta Scholarships in one of following two ways:

- 1. <u>Login</u> to your Alberta Student Aid Account and securely upload all required sections of the application and any supporting documents.
- 2. Fill out and mail applications and any supporting documents to:

# **Application Processing Timelines**



For scholarships and awards administered by Alberta Student Aid, a completed application and any documents required to confirm the student's eligibility must be received by Alberta Student Aid within 30 days of the date of the request, or if an Information Request letter is received by the student, by the date indicated in the Information Request letter.

Applications and/or any documents received after this date will not be considered, except in exceptional circumstances which are determined on a case-by-case basis. These parameters may not apply to scholarships and awards administered directly through post-secondary institutions.

An application is not considered complete until:

- all documents listed as required on the application are received, or
- all requested missing information has been submitted.

#### **Disbursements**

A student will have their scholarships and awards disbursed when the:

- · student has met all the scholarship or award eligibility criteria, and
- student has been selected as the recipient of the scholarship or award, and
- student's post-secondary institution has confirmed full-time registration for the study period, if required.

If a cheque is issued to the student by Alberta Student Aid for scholarships and awards delivered through Advanced Education, the cheque must be cashed within 180 calendar days. The student will need to contact Alberta Student Aid to have a cheque reissued after 180 days.

# **Replacing Cheques**

Students who have not received, or who have lost a scholarship or award cheque issued by the Government of Alberta may request a replacement cheque as described below:

For the replacement of Alberta scholarship or award cheques, contact:

A student may request a replacement cheque if the student has not received or has lost the original cheque, or if the cheque has expired. If the cheque has not been cashed and the student is still eligible for the scholarship or award funding, a stop payment will be placed on the original cheque and a

replacement cheque will be issued.

If the cheque has been cashed, an investigation is required before a replacement can be issued. If the student believes the cheque was fraudulently endorsed and cashed, a copy of the cashed cheque will be sent to the student along with the Alberta Forgery Statutory Declaration form. To initiate an investigation, the form must be completed by the student and a Notary Public. The original signed form must then be returned to Alberta Student Aid.

If you have not received your scholarship or award by the end of April, call the Service Centre on the contacts listed above.

#### Alberta Student Number

All students must provide an Alberta Student Number (ASN) on their student aid application. The ASN is a single, unique ID number assigned to all Alberta learners from kindergarten through to post-secondary studies. The ASN is recorded on an Alberta Transcript of High School Achievement or can be found online at <a href="Learner Registry">Learner Registry</a>. Students who have never attended school in Alberta must apply for an ASN on this website.

# **Confirmation of Registration**

Before any funding can be issued to a student, Alberta Student Aid must receive confirmation the student is enrolled full-time for the applicable study period, if the scholarship or award is administered by Advanced Education.

Alberta Student Aid will confirm full-time enrolment with the appropriate post-secondary institution. This process is known as Confirmation of Registration (COR). If there is a problem contacting and receiving the required COR documents, you may be asked to provide COR information.

# **Tax Forms**

T4As are issued by Advanced Education when a student receives more than \$500 of scholarship or award funding per calendar year.

T4As are issued for the calendar year in which the scholarship or award amount was paid – not for the year in which the scholarship or award was scheduled to be disbursed.

Students with questions about the tax implications of their scholarships and awards should contact the Canada Revenue Agency or speak to their accountant.

# **Disclosure of Personal Information and Authorizing Others to Act on Your Behalf**

The *Freedom of Information and Protection of Privacy Act* (Alberta) (FOIP) governs the collection, use and disclosure of information for Alberta Advanced Education – Alberta Student Aid.

The Application for scholarships and awards provides information about the individuals or entities that Alberta Student Aid may disclose the student's personal information to. Other disclosures may also be authorized by the FOIP Act.

The student may also give direction to Alberta Student Aid through a Power of Attorney or Consent to Disclose.

# **Power of Attorney**

A student may complete an Alberta Power of Attorney form to allow another person to act on the student's behalf with respect to funding from Alberta Student Aid and to receive the student's personal information.

The Power of Attorney form allows the student's attorney to take any action on the student's behalf other than completing an application for scholarships and awards. The Power of Attorney form grants authority for a 5-year period unless it is revoked sooner by the student.

#### **Consent to Disclose**

To authorize someone to receive personal information, the student must submit written consent to Alberta Student Aid identifying:

- the person(s) authorized to receive the information
- relationship of the student to the authorized person(s)
- the type of personal information Alberta Student Aid is authorized to disclose, and
- the time frame for which the consent is in effect.

The Consent to Disclose form is the best way for a student to provide this authorization.

The Consent to Disclose form does not authorize the person identified in the form to take any action or make any changes to a student's application. It only allows for release of information to the identified person under the conditions described on the form.

A one-time verbal authorization by the student to disclose information is also acceptable



# Alexander Rutherford Scholarship for High School Achievement

**Purpose** To recognize and reward academic achievement of senior

high school students and encourage them to pursue post-

secondary studies.

**Value** Up to \$2,500

**Lifetime Maximum** One scholarship

# **Eligibility Criteria**

#### Citizenship and Immigration Status

AHS Reg.: ss. 1(g) and 2

To be eligible for the Alexander Rutherford Scholarship for High School Achievement, a student must be a:

- Canadian citizen, or
- permanent resident of Canada, or
- protected person, as defined in the *Immigration and Refugee Protection Act* (Canada).

A student must have a valid Canadian Social Insurance Number (SIN) to be eligible for financial assistance from Alberta Student Aid. Students with questions about applying for a SIN may contact Service Canada at 1-800-206-7218.

Protected persons must be able to document that their protected person status is valid at the start of their current study period.

Protected persons must provide copies of the following documentation:

- a temporary Social Insurance Number (SIN) card or confirmation of SIN letter showing a 900 series SIN number, and
- a Notice of Decision issued by the Immigration and Refugee Board or Verification of Status document issued by Immigration, Refugees and Citizenship Canada. Protected Persons Status Documents issued prior to January 2013 are acceptable as well.

Students with only a study permit or a work permit (e.g., visa students) are not eligible.

Students must also meet Alberta residency criteria and other eligibility requirements to be eligible.

#### Residency

AHS Reg.: ss. 1(g) and 2(4)

To be eligible for the Alexander Rutherford High School Achievement Scholarship, a student must be an Alberta resident at the time of high school grades.

To be considered an Alberta resident, one of the following conditions must apply:

- one parent or legal guardian has maintained permanent residence in Canada for at least 12 consecutive months immediately prior to commencing post-secondary studies and be residing in Alberta, or
- Alberta is the last place the student has maintained permanent residence for 12 consecutive months immediately prior to commencing post-secondary studies.
- a person or member of a class of person declared by the Minister to be a resident.

Additionally, a student is not eligible to receive a scholarship with respect to any grade unless the student or the student's parent(s)/legal guardian were a resident in Alberta throughout the whole of that grade.

# **Border Community**

AHS Reg.: ss. 1(b) and 2

As the town of Lloydminster is a border community located both in Alberta and Saskatchewan, all students living in Lloydminster are eligible. Students must live in Lloydminster and attend Holy Rosary High School or Lloydminster Comprehensive High School. The student may be required to submit their transcript.

# **Program Eligibility**

To be eligible for the Alexander Rutherford Scholarship for High School Achievement, a student must be:

 enrolled in at least 60% of a full course load during a semester in an undergraduate post- secondary program of study at a Minister approved or designated post-secondary institution in Alberta or elsewhere, or

- enrolled in at least 60% of a full course load of a post-secondary program at a private career college in Alberta or elsewhere (licensed under the Private Vocational Training Act),
  - A post-secondary program at a private career college is considered full-time when the licensed post-secondary program is 12 weeks or longer and has 20 or more instruction/practicum hours per week.
- registered in an apprenticeship education program as defined in the *Skilled Trades and Apprenticeship Education Act (STAEA)*.

A student enrolled in Open Studies is eligible provided the student is enrolled in full-time post-secondary studies (at least 60% of a full course load at the post-secondary institution).

A student enrolled in an upgrading program, a graduate program, or professional program is not eligible.


A professional program means:

- a winter-session course at The Banff Centre, and
- a program of study at a post-secondary institution in medicine, law, dentistry, pharmacy, optometry, veterinary medicine, chiropractic studies, or any other program that exceeds a total of four years of post-secondary education and is designated by the Minister as a professional program.

#### **Designated Programs**

A designated program is an undergraduate program with a minimum course length of 17 weeks of full-time post-secondary studies and when approved by the Minister of Advanced Education allows eligible student to apply for student loans, grants, scholarships, and awards. See the <u>Designation for Loans and Grants</u> in the Student Aid Policy Manual for more information.

# **Qualifying High School Course Requirements**



A student must have completed high school on or after September 30, 1980 in order to be eligible. The official mark found on an Alberta Transcript of High School Achievement is used in the assessment of the Alexander Rutherford Scholarship.

Course requirements and award amounts will also vary depending on when a student graduated from high school.

#### **Completion or Graduation Date**

As a general rule, the graduation date is the date, which appears on the official high school transcript. If the student did not graduate, the completion date is determined using the most recent academic year where three or more courses were completed as indicated or shown on the high school transcript.

#### **Green Certificate Courses**

Green Certificate courses are accepted as options for Grade 12. These courses are not sequential and may be taken in any order. Each Green Certificate course is coded as a 33 Grade 12 level and all credits earned in Green Certificate courses count toward Grade 12 graduation requirements.

The Green Certificate Program allows students in Grades 10, 11 and 12 to participate in an agriculture-related apprenticeship, earn credits and complete the Technician Level of a Green Certificate in any one of nine specializations. It consists of 21 courses in seven primary agricultural specializations.

#### Alberta Home Education

Home education may be eligible as long as your program follows the Alberta Programs of Study curriculum. Students in home education must obtain both course evaluations and recommendations for credits from a high school principal and an official Alberta Transcript of High School Achievement.



## **Application Process**

If the program of study used on the application is not eligible for the New Beginnings Bursary, the application will not be considered.

#### **Selection Process**

Alberta Student Aid will select recipients by looking at the pool of student loan borrowers who have completed applications for full-time loans for the current loan year and by applying the bursary eligibility criteria.

Eligible completed applications will be selected in the order they were received.

An individual may receive a lifetime maximum of two bursaries.

## **Eligibility Criteria**



## **Program Eligibility**

To be eligible for the Northern Alberta Development Bursary Program, a student must:

- Be enrolled in a full-time program in a post-secondary institution that is designated for provincial funding.
- Be registered in a program that is at least 12 weeks in length to be eligible for half a bursary or 16 weeks in length to be eligible for the full bursary.
  - Preference will be given to students attending a study period of at least two semesters in length if there are more applicants than available bursaries.
  - Students enrolled in apprenticeship classroom instruction, integrated training, pre-employment, or non-credential programs are not eligible.
- Not be in default of an Alberta student loan.
- Be a resident of Alberta for 12 consecutive months before the start of their program.
- Be 18 years of age or older.
- Live and work for one year of full-time employment in northern Alberta for each year of bursary funding.
  - Students have up to six months after graduation to find employment related to their fields of study.

## **Northern Alberta Development Council Bursaries**



The following specialty bursaries fall under the Northern Alberta Development Bursary:

- Northern Alberta Development Council Bursary a return of service bursary of up to \$7,000 per year (for a maximum of two years) for students completing their final two years of post-secondary studies. It is an incentive to encourage students to train for high demand jobs in northern Alberta including education, social work, medical and health, engineering, and technical fields.
- Medical and Dentistry Student Bursary a return of service bursary of up to \$14,000 per year for the full length of the medical program (maximum four years).

It is an incentive to encourage Alberta medical or dentistry students to practice in northern Alberta upon graduation.

- **Nurse Practitioner Bursary** a return of service bursary of up to \$10,500 per year for the full length of the practitioner program (maximum three years). It is an incentive to encourage nurse practitioners to practice in northern Alberta upon graduation.
- **Pharmacy Student Bursary** a return of service bursary of up to \$7,000 per year for the full length of the pharmacy program (maximum four years). It is an incentive to encourage Alberta pharmacy students to live and work in northern Alberta upon graduation.
- **Veterinary Student Bursary** a return of service bursary of \$7,000 per year for the full length of the veterinary program (maximum four years). It is an incentive to encourage Alberta veterinary students to live and work in northern Alberta upon graduation.

## **First Nations Métis and Inuit Bursary**



SFA Reg.: Schedule 2, s. 23

The First Nations Métis and Inuit Bursary is a return of service bursary for First Nations, Métis and Inuit students of varying amounts:

- Students in pre-apprenticeship training, or in a certificate or diploma studies can access up to \$7,000 for their studies.
- Students in a Bachelor's, Masters', or PhD program can access \$11,500 per year for any year of their studies.
- Students must provide proof of Indigenous ancestry First Nations status card, Métis card, Inuit card, letter from the Band or Métis Settlement, or a letter from an Indigenous organization the student is actively involved with.

## **Bursary Partnership Program**



SFA Reg.: Schedule 2, s. 23

The Bursary Partnership Program is a return of service bursary that encourages employers or organizations to invest in northern Alberta by sponsoring post-secondary students.

• The program will match sponsor's amount of up to \$3,500 per student per year.

#### **Selection Process**

A selection committee chooses recipients based on the pool of applicants and the following criteria:

- program of studies and the demand for career program in northern Alberta,
- knowledge of northern Alberta,
- academic record,
- answers to essay questions, and
- financial need.

#### **Payment**

The bursary payment will be made after the recipient signs the return of service agreement and Alberta Student Aid confirms the recipient's confirmation of eligibility.

#### **Events of Default**

A student commits an Event of Default under a return of service agreement if the student:

- does not use the bursary for the purposes of which it was intended;
- is no longer a full-time student in the program of study for which the bursary was given;
- withdraws from their program of study (voluntarily or otherwise);
- fails to maintain a passing grade in the program of study in any academic year;
- fails to notify the Minister of Jobs, Economy and Trade (JET) of change to the student's educational status or contact information within 30 calendar days;
- fails to obtain full-time employment in a related field of study within 6 months of completion of their program of study;
- fails to continue the full-time employment for the full amount of the Return of Service Period, unless otherwise approved by the Minister of Advanced Education;
- fails to maintain a full-time residence within the NADC Boundary;
- fails to provide written information regarding the student's employment status and location of employment and residence; or,
- was not entitled to receive all or part of the bursary, as determined by the Minister of Advanced Education.

In the event that the student commits an Event of Default, the student is responsible for paying the Bursary Repayment to the Minister. The Minister may consider any partial fulfillment of the Return of Service Period and reduce the Bursary Repayment on a prorata basis.

If the student commits an Event of Default, the Minister of Advanced Education will give written notice to the student advising the student of the amount of the Bursary Repayment and require the student to make the required Bursary Repayment to the Crown.

- If the student has a direct loan, as defined in Schedule 2 of the Student Financial Assistance Regulation, the amount of the Bursary Repayment will be added to the balance of that direct loan.
- If the student does not have a direct loan, the amount of the Bursary Repayment will be converted to a direct loan that is deemed to be made under Schedule 2 of the Student Financial Assistance Regulation and set the terms and conditions of that direct loan.

#### **Deferral Process**



Decision-making authority for the NADB program falls under Advanced Education and the Student Financial Assistance Regulation Section 17 & 23 – Northern Alberta Development Bursary. Advanced Education works with the Ministry of Jobs, Economy and Trade to administer and deliver the program.

A maximum of two deferrals can be granted per student for a maximum of 24 months.

The following outlines the deferral process as established by Advanced Education and Jobs, Economy and Trade. A deferral request may occur when student is not meeting their obligations under the Return of Service agreement they have signed with the Minister of Advanced Education.

The student may request a deferral of the time to find employment or to complete the Return of Service Period under certain circumstances. The student should contact the Jobs, Economy and Trade program officer to request a deferral.

#### Tier 1 Deferral Review is completed by Jobs, Economy and Trade:

The Program Advisor at Jobs, Economy and Trade has the authority to grant deferrals for the following reasons and length of time:

#### **Change in Field of Studies**

Students may change their field of studies while attending post-secondary studies. The new field of studies will be used for return of service provided the new field is in a high or medium demand occupation as listed in the current occupations scoring guide at the time of the change, and not at the time of the award being granted. If the new field of studies does not meet this requirement, the bursary will be converted to a loan and will follow the <u>repayment process of an Alberta Student Loan</u>.

#### Tier 2 Deferral Review is completed by Advanced Education:

Any other request that falls outside of those listed in Tier 1 will need to be reviewed to determine if it is an exception that should be made on a case-by-case basis.

After Jobs, Economy and Trade has advised the student that they are not meeting the terms of the agreement and their bursary will be sent for repayment, the student may request a review provided there is a special circumstance.

- Special circumstances may include medical issues or problems, injury, or unique situations where it is not possible to meet the terms of the agreement, or where additional time may be required to find employment in the student's field of study.
- A special circumstance does not include the desire to live and work outside of the NADC Boundary.

The student will be asked to provide a request for deferral due to their special circumstances to <a href="mailto:bursariesnad@gov.ab.ca">bursariesnad@gov.ab.ca</a>. The student will need to clearly indicate what

they are requesting and provide rationale (e.g., seeking approval to allow employment to be used towards their return of service obligation).
